Tour 2 Score Soccer Game Tickets Giveaway Official Rules

THE CONTEST: The “Tour 2 Score Soccer Game Tickets Giveaway” contest (the “Contest”) will award two tickets to a World Championship Soccer Game held on Saturday, July 4, 2026 (“Contest Prize”).

ENTRANTS MUST CONSENT TO FILLING OUT PERSONAL INFORMATION IN ORDER TO PARTICIPATE. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes Entrant’s full and unconditional agreement to and acceptance of these Official Rules. The Contest begins at 12:00:01 a.m., Central Daylight Time (“CDT”) on May 1, 2026 and ends at 11:59:59 p.m. CDT on June 28, 2026 (“Contest Period”).

ELIGIBILITY: This Contest is open to all legal residents of the United States and District of Columbia who are 21 years of age or older as of the Contest Start Date. The contest is open to (a) members of the general public and (b) licensed real estate agents. Only one (1) winner will be selected from among all eligible entries received during the Contest Period.
